#### 7. Raines vs. CCCERA et al

It was M/S/C that Sheila Raines has dismissed her lawsuit against CCCERA with prejudice in exchange for a waiver of costs. There were no costs for CCCERA to recover in this case and by a vote of 9 to 0; CCCERA's Board therefore has agreed not to pursue Ms. Raines for costs. ## 9. Pension Administration Project

Leedom provided an update on the Pension Administration Project. She noted the challenge of transferring retiree data correctly from the legacy system into the Tier System. The system is scheduled to go "live" in late October or November with the first checks from the Tier System going out December 1, 2006.

Leedom has been meeting with the County's Human Resource (HR) Benefits office regarding health insurance carrier deductions for safety retirees on CALPERS medical insurance. She noted a letter was mailed from HR to these retirees to request their

authorization to have deductions for insurance taken from their retirement checks. The County will continue to collect premiums if no authorization form is received from the affected retirees.

Leedom then noted she is still in discussions regarding safety members' pre-tax healthcare deductions as it relates to the Pension Protection Act. She then shared a copy of the new checks with Board members and noted the tax form, 1099r, will be laser printed and easier to read.

Additions for next year will include a member web site that will include personal identification numbers (PINS) for members to access information.

## 10. SACRS Ad-Hoc Nomination Review Committee Recommendations

After discussion on the language used in the SACRS Ad-Hoc Nomination Review Committee recommendations, it was M/S/C to approve the recommendations of the SACRS Ad-Hoc Nomination Review Committee. (Yes: Cabral, Gaynor, Gioia, Hast, Katz, Pollacek, Rey, Telles, and Wedington

## 11. Market Stabilization Account

Leedom reviewed the Market Stabilization Account as of June 30, 2006, noting she has basic information available for the Board. If more in-depth information is needed the item will need to be re-agendized when Koehler returns. It was the consensus of the Board to have the Market Stabilization Report re-agendized when Koehler returns.

## 12. Normal Retirement Age

There was a motion to direct staff to work in association with The Segal Company, to study, define and standardize the terminology "normal retirement age", as it applies to all tiers within the retirement system. The motion was amended to attempt to have all other '37 Act systems develop the same procedures and to return to the Board with a recommendation.

There was continued discussion on working with SACRS to have all '37 Act Counties follow the same procedures to prevent several different processes. Leedom noted she would place this as a topic of discussion at the Administrator's break-out session at the upcoming Fall SACRS Conference. The second on the motion was withdrawn.

Dunning noted she is working with Ice Miller to assist in a definition of normal retirement ages for CCCERA. Some preliminary steps can be completed before procedures for all '37 Act systems are determined.

<u>Hally</u> noted Arthur Hidalgo, who is well-known to the Board, but has no input on investment processes has left Adelante. He apologized for neglecting to inform the Board before this time and noted he should have mentioned this previously. <u>Cabral</u> noted his concern, commenting it was the decision of the Board to place an investment manager on "Watch". <u>Hally</u> noted, in the future, if someone is a primary contact, he will attempt to let the Board know as soon as possible. <u>Leedom</u> commented perhaps the quarterly reports should be changed to include client service contacts who are leaving the firm. <u>Hally</u> will make an effort to include the departing client contacts in his reports to the Board.
