4. Disability Retirements

It was **M/S/C** to accept the Medical Advisor's recommendation and grant the following disability benefits:

5. Donald Leverton

It was **M/S/C** to accept the recommendation of County Counsel to grant a service connected disability retirement for Donald Kent Leverton. (Yes: Cabral, Gaynor, Gioia, Hast, Pollacek, Rey, Telles, and Viramontes)

6. Other Litigation

No reportable action taken.

7. Legal Service

Staff reviewed the recommendation of the ad hoc committee for General and Fiduciary counsel. It was noted the recommendation from the committee was to hire one firm for both General and Fiduciary counsel. The ad hoc committee also recommended that the proposed firm be willing to help CCCERA recruit and train for the on staff General Counsel Position. There was discussion on the desire to have CCCERA's General Counsel represent only one '37 Act County as general counsel, the strengths of the individual firms, and a request that any future counsel changes should to go through a Board presentation process.

It was **M/S/C** to accept the recommendation of the Ad hoc Committee to retain Reed Smith LLP, contingent upon successful completion of the on-site visit, contract negotiations, board meeting attendance, and any other issues that may occur as a result of these processes; and to authorize the CEO to sign the contract; Reed Smith, LLP, upon finalization, will provide both Fiduciary and General Counsel Services to CCCERA, with an implementation date of April 1, 2008 as outlined in the ad hoc committee report; Manatt, Phelps and Phillips will continue to work on certain pending items that require follow up and in circumstances where conflicts of interest may exist, and for special litigation as issues occur. SACRS audited financial statements will be in the library. SACRS is requesting appointed trustee volunteers for an ad hoc committee regarding the possibility of creating a paid CEO position for SACRS.

Leedom stated Disclosure Statement, Form 700, is due by April 1st. She noted adopted assumptions approved during the actuarial valuation last year were approved for three years; however, an annual valuation will still be completed.

As a reminder, Leedom noted rooms for the SACRS conference were reserved for all Board members and if not attending, please inform staff so hotel rooms can be released for others attending the conference.

- (c) Trustees' Comments - Cabral reported he attended the Klausner Conference. The report will be in future agenda packet. He requested a work shop to determine how CCCERA policies can be strengthened to comply with the OPEB Commission report.

Pollacek reported that he visited Katz and noted he is looking good. He is still in a skilled nursing facility, but may go home soon.


