### **5. Routine Items**

It was *M/S/C* to approve the routine items of the May 5, 2010 meeting. (Yes: Cabral, Gaynor, Hast, Holcombe, Naramore, Pollacek, and Viramontes)

The Board moved into closed session pursuant to Govt. Code Section 54957 to consider the Medical Advisor and or staff's recommendation regarding disability retirement applications and to consult with counsel concerning cases currently being litigated.

The Board moved into open session.

### **6. Disability Retirements**

It was *M/S/C* to accept the Medical Advisor's recommendation and grant the following disability retirement:

(a) Janice Davis Service Connected (Yes: Cabral, Gaynor, Hast, Holcombe, Naramore, Pollacek, and Viramontes)

### **7. SACRS Bylaws Amendments**

The Board reviewed the proposed nominating committee amendments to the SACRS Bylaws. Concerns were raised regarding future vacancies as well as no longer allowing nominations to come from the floor. The Board directed Pollacek to vote no on accepting the amendments to the SACRS Election Bylaws.

Discussion followed regarding the SACRS draft proposal concerning the Board of Directors Governance amendment to the SACRS Bylaws. The Board does not believe the proposed actions improve the governing process and directed Pollacek to vote no on the action items.

### **8. Central Contra Costa Sanitary Districts Information Request**

Randall Musgraves addressed the Board requesting Central Contra Costa Sanitary District's request for actuarial information the Segal Company in regards to the depooling by employer process. He noted that Central Sanitary District is requesting all pertinent data prior to the Board adopting new contribution rates on this issue. He also requested enough time for the District's actuary to audit the information before adoption of new rates.

Leedom was directed to compose a letter to all employers, outlining the depooling process to ensure they are well informed. The Board will also provide ample time for employers to review the Segal Study, audit information as needed and respond, prior to making a final decision on contribution rates as a result of depooling.

**9. CCCERA Position Changes**

Leedom discussed concerns regarding current CCCERA staffing levels and Human Resources' unwillingness to create any additional job titles designated as "retirement" including two new positions the CCCERA Board approved in late 2009.

It was **M/S/C** to approve CEO's recommendation of three additional positions:

1. Retirement Senior Member Services Data Specialist (RSMSDS) using the existing funds from the Retirement Counselor III position. This job title already exists within Retirement job classifications.
2. Retirement Accounting Specialist (RAS) using the budgeted funds for the Retirement Accounting Technician. This title exists within the County Human Resources job descriptions. The job duties are similar to those described in our previously approved Retirement Accounting Technician.
3. Retirement Office Specialist (ROS) to perform a variety of clerical tasks. This individual would be cross-trained to provide clerical assistance to Legal Counsel and Communications, in addition to improving day-to-day workflow in the Administration Division when other personnel are absent.

Levy noted the '37 Act Law book updates will be distributed with a memo attached.


